1. The open auction will be held on 14-06-2021 at 11:45 am building no 2 street 39 G-10/4 Workers Welfare Islamabad. The vehicle may be inspected at the above mentioned address during working hours from 24-05-2021 to 6-06-2021.
2. Pay order amounting to Rs 150000/- (One Hundred and Fifty Thousand Only) in favour of Workers Welfare Fund shall be deposited at the time of auction by the participant to become eligible for participating in the auction process. The bidder must bring their original CNIC and provide complete address / telephone numbers and attested copy of CNIC on the day of auction. The pay order of the unsuccessful bidder will be released on the same date ie. Auction date.
3. Successful bidder must deposit 25 % of the bid on spot and the remaining amount must be deposited within 10 days of auction. In case of default the amount deposited shall be forfeited.
4. The payment of outstanding token tax will be the responsibility of successful bidder.
5. The transfer of ownership documents would be the responsibility of the successful bidder.
6. Vehicles along with the documents will be handed over after complete payment only.
7. Taxes shall be charge as per prevailing law.
